THE ROLD 2020 PROGRAM – THE RESILIENT LEADER

The RoLD 2020 Program, comprised of the flagship courses on the Rule of Law and Development, aims to bring together resilient leaders from diverse fields to learn about the intricacies of the rule of law and its importance amid the societal upheaval during the pandemic with the hope to create a more peaceful and just society as the foundation for sustainable development.

CORE CURRICULUM

1. INTRODUCTORY TO SDGS AND THE RULE OF LAW

Signifies collaborative efforts in bringing together emerging leaders, scholars and policymakers to learn from like-minded peers about the intricacies of the rule of law in contemporary contexts, which seeks to strengthen human capacities to formulate and develop a true understanding of how the rule of law operates within our multi-faceted society.

2. SPECIAL LECTURE SERIES (Conducted in Thai)

On-site lecture series to learn from invited keynote speakers of their first-hand experiences on the cross-cutting global law and policy trends.

3. GLOBAL WEBINAR SERIES (Conducted in English with simultaneous Thai translation)

Interactive online discussions hosted by the Institute of Global Law and Policy (IGLP) at Harvard Law School on the challenges and impacts related to the COVID-19 crisis, including:

- 1) Comparative regulatory responses
- 2) Social justice, poverty and inequality
- 3) Criminal justice reform
- 4) Development and global production chains
- 5) Labor, education and the future of work
- 6) Global governance and multilateralism

4. PROBLEM LABS: EXECUTIVE FUTURE THINKING FOR JUSTICE SERIES (Conducted in English, no translation)

Provides participants with unique hands-on introductory sessions to innovative problem solving through the lens of future thinking. The Problem Labs curriculum features creative forward-looking tools and methods to engineer timely and long-term solutions for justice issues.

5. TIJ-IGLP WORKSHOP FOR EMERGING LEADERS ON THE RULE OF LAW AND POLICY (Conducted in English, no Translation)

Opportunities to share practical policy initiatives, discuss about novel approaches to complex socio-economic problems, cultivate skills in offering feedback, present and synthesize on the ground experiences in a policy discourse framework, as well as benefit from peer-to-peer engagement with mentorship from experienced IGLP faculty members.

6. FIELD TRIPS

Exclusively organized for emerging leaders to witness policy development at work.

7. TIJ INTERNATIONAL FORUM (Conducted in English with simultaneous Thai translation)

Participants will hear from invited experts on the application of the rule of law and its positive impacts to create meaningful changes around the globe. Selected participants will also present their views and concluding thoughts to over 200 attendants from public and private sectors at the TIJ International Forum on the Rule of Law and Sustainable Development.

8. VALUED NETWORK OF LEADERS & POLICY MAKERS

The objective of the RoLD 2020 Program is to cultivate an appreciation of the importance of the rule of law, particularly its fundamental role in the achievement of sustainable development. It provides a platform that encourages constructive discussion among practitioners across sectors and promotes interactive learning through experience sharing. With a deeper understanding of how and why the rule of law is essential for sustained and inclusive economic growth, human rights protection and sustainable development, participants will become a part of a new network of emerging leaders who will act as agents of change in their respective fields and bridge thinking into practice.
